Welcome and Introductions / brief announcements

The meeting was called to order at 2:08 pm by Chair Phil Prete. Attendees introduced themselves and the organizations they represent.

- New Hanover SWCD seeking to fill a vacancy on the district board contact Dru Harrison if interested
- DCM, CAMA and USACE permits acquired for paddle trails; company to donate pipes; Rob Moul has a boat and is willing to install as needed
- Battleship update ready to carry forward the overnight camping project (can accommodate 100+ children); Battleship Capital Campaign underway – over \$4.5M pledged for construction projects including a kayak launch
- Cape Fear River Watch working hard on fish restoration projects on the river

Phil Prete shared map of Eagles Island; all properties north of the causeway are in public ownership with the exception of the Stone Tug property (river front near the Battleship) and the McLaughlin tract (northern-most tract). Opportunities may be available to protect these properties (by obtaining title or easement) with funds available through Tronox settlement. Meeting with Stone Tug owners is planned for tomorrow, and initial conversation has been started with McLaughlin heirs to determine if options to purchase can be agreed upon.

Two additional properties (DOT owned and "horseshoe" owned by Duke Progress) may be possibilities for donation.
